GRASS LAKE CHARTER TOWNSHIP JACKSON COUNTY, MICHIGAN ORDINANCE NO. 23-14

LARGE SOLAR ENERGY SYSTEM EMERGENCY MORATORIUM ORDINANCE

At a meeting of the Township Board of Grass Lake Charter Township, Jackson County, Michigan, ("Township") held at the Grass Lake Charter Township Hall, on the <u>10th</u> day of <u>October</u>, 2023, at <u>6:30</u> p.m., <u>Lesinski</u> moved to adopt the following emergency Ordinance, which motion was seconded by <u>Bednarski-Lynch</u>.

An emergency ordinance to enact a temporary moratorium until October 1, 2024 or an earlier time in which the Township adopts new regulations governing Large Solar Energy Systems and rescinds this Ordinance, on the application, permitting, consideration, approval, location, erection, construction, and/or installation of any Large Solar Energy Systems projects or other solar energy projects which require a special land use permit.

WHEREAS, the Township has adopted a zoning ordinance and other ordinances, including a zoning ordinance amendment which regulates, among other things, the Large Solar Energy Systems land use (the "Solar Ordinance"). Large Solar Energy Systems are generally a utility-scale solar energy project designed for generating electricity for off-site users; and

WHEREAS, the Township has applied the Solar Ordinance including approving one such land use. Due to concerns from the public and Township officials about appropriate regulations to regulate the Large Solar Energy Systems land use, among other potential issues associated with Large Solar Energy Systems such as glare, appropriate setbacks, impacts to farmland, noise impacts, and other concerns, the Township wishes to engage in a review of its existing Solar Ordinance and possibly revise regulations governing Large Solar Energy Systems; and

WHEREAS, the Township has a legitimate purpose in addressing the proper, design, size, location, and operation of Large Solar Energy Systems in the Township; and

WHEREAS, the Township is reasonably concerned that continued application of the Solar Ordinance could cause future Large Solar Energy Systems to be established in inappropriate or inadvisable locations within the Township; and

WHEREAS, it is appropriate to forestall such issues for the Township and to enact a temporary moratorium on Large Solar Energy Systems until any necessary revised regulations can be entered; and

WHEREAS, time is of the essence to implement this moratorium to avoid potential developers applying for a Large Solar Energy System land use and a moratorium being enacted as well as given the immediate interest in the land use within the Township; and

WHEREAS, the Township determines that the adoption of this emergency Ordinance, which is necessary to preserve the public peace, health, and safety by preventing the inappropriate location and establishment of Large Solar Energy Systems in the Township during the time needed to study, review, and potentially revise the Township's current Solar Ordinance due to changed conditions within the Township.

NOW, THEREFORE, the Charter Township of Grass Lake Ordains:

Section 1. Title: This Ordinance shall be known and cited as the Grass Lake Charter Township Large Solar Energy System Emergency Moratorium Ordinance.

Section 2. Moratorium: The Township enacts a temporary moratorium on the permitting, consideration, approval, location, erection, construction, and/or installation of all Large Solar Energy Systems or any solar energy project requiring a special land use permit in the Township until October 1, 2024 or an earlier time in which the Township adopts new regulations governing Large Solar Energy Systems and rescinds this Ordinance. This Ordinance shall not apply to and have no effect on Large Solar Energy Systems approved prior to the effective date of this Ordinance. The Township Board by resolution may extend the time of this moratorium under this Ordinance in increments of six month.

Section 3. Severability: The provisions of this Ordinance are hereby declared to be severable and if any part is declared invalid for any reason by a court of competent jurisdiction it shall not affect the remainder of the Ordinance which shall continue in full force and effect. Should this Ordinance be determined by a court of competent jurisdiction to be invalid, it shall be considered a resolution under MCL 42.20(1) pertaining to the internal affairs of the Township determining the timing of when it will administratively consider and process land use applications and requests.

Section 4. Repeal: All ordinances or parts of ordinances in conflict with this Ordinance are hereby repealed.

Section 5. Emergency Ordinance & Effective Date: This Ordinance shall take effect immediately after publication. Pursuant to MCL 42.20, this Ordinance is declared to be an emergency ordinance, which may be passed at the same meeting at which it is introduced. Factors necessitating this Ordinance to be declared as an emergency ordinance, include, but are not limited to, an urgency to forestall applications for the land use under potentially inappropriate current regulations which if this Ordinance is not passed at the same meeting it is introduced may cause the Township to receive various applications upon introduction.
